### ***Conestoga Wood Specialties v. Sebelius***

#### ***ABOUT Conestoga Wood Specialties v. Sebelius***

The owners of Conestoga Wood Specialties, the Hahns, are a practicing and believing Mennonite Christian family. They desire to run the company, a wholesale manufacturer of custom wood kitchen cabinet parts, in a manner that reflects their sincerely held religious beliefs, including their belief that God requires respect for the sanctity of human life. Alliance Defending Freedom attorneys and allied attorneys represent the Hahns in a federal lawsuit against the Obama administration over its abortion pill mandate. The mandate forces employers, regardless of their religious or moral convictions, to provide insurance coverage for abortion-inducing drugs, sterilization, and contraception under threat of heavy penalties by the U.S. Department of Health and Human Services if the mandate's requirements aren't met. After the U.S. Court of Appeals for the 3rd Circuit ruled in favor of the Obama administration, the U.S. Supreme Court agreed to hear the case along with another case, *Hobby Lobby Stores v. Sebelius*.

#### ***CURRENT STATUS OF Conestoga Wood Specialties v. Sebelius AS OF 2/6/2014***

Alliance Defending Freedom attorneys [filed their opening brief](#) at the U.S. Supreme Court on Jan. 10. [Fifty-nine friend-of-the-court briefs were filed](#) in support of Conestoga Wood Specialties and Hobby Lobby Stores by the end of January—outnumbering the number of briefs filed in support of the abortion pill mandate by nearly 3-1. The Obama administration's response brief is due Feb. 10, and Conestoga's reply is due March 10. The U.S. Supreme Court will hear oral arguments on March 25.
